Editorial

Migration in 2022 was marked predominantly by the impact of the war in Ukraine. Added to this were the rising numbers of asylum applications and high demand from the Swiss economy for foreign labour. This is reflected also in the statistics: the State Secretariat for Migration (SEM) registered 74 959 applications from Ukrainian nationals for protection status S, 24 511 asylum applications and a net immigration of the permanent foreign population of 81 345 persons.

The millions of people who fled to Central Europe and Switzerland from the war in Ukraine were a key factor in migration over the last year. On 12 March 2022, the Federal Council activated protection status S: in the first six weeks alone, more than 40 000 people seeking protection from the war were permitted to enter Switzerland.

In 2022, SEM received 9 583 more asylum applications than in the previous year – an increase of 64,2 %. The increase is due to several reasons. For one thing, travel has become easier again after the lifting of pandemic-related measures. In addition, the pandemic has weakened many of the economies in those countries of origin and transit from which asylum seekers traditionally come. What is more, the situation has been further exacerbated by rising prices as a result of the war. These circumstances have increased the pressure on the native and migrant populations of the countries affected to migrate, including on those who have lived there for some time.

Immigration to Switzerland is determined largely by the demand for labour. Thus, the number of foreign immigrant workers increased significantly in 2022 (+26 %). At the same time, emigration remained stable. At the end of December 2022, 2 241 854 foreigners were living permanently in Switzerland.

These and more findings are provided by the 2022 statistics on foreign nationals and asylum seekers. I wish you an interesting read!

Introduction

[Foreign Population and Asylum Statistics – an overview](#)

The statistics published by the State Secretariat for Migration (SEM) provide a wealth of useful information on Switzerland's foreign resident and asylum-seeking populations, their origins, their territorial distribution and their demographic profile. They also include retrospective spreadsheets (spanning 4-, 5-, 10- and 20-year-periods) which factor in additional criteria arising from federal legislation on the residence and permanent settlement of foreign nationals as well as the new requirements resulting from the Agreement on the Free Movement of Persons between Switzerland and the European Community (EU) and the European Free Trade Area (EFTA).

[Differences from Federal Statistical Office \(FSO\) statistics](#)

Although the statistics presented here deal with the size of the foreign permanent and non-permanent resident population, asylum seekers and demographic changes, the data do not include diplomats who hold a permit issued by the Federal Department of Foreign Affairs, international officials and members of their families who are not in gainful employment. The SEM largely uses the same terms as Federal Statistical Office (FSO) for its foreign population statistics. However, the data sources differ, as do the definitions of certain categories. As a result, numerical differences in certain sets of statistics may arise.

For example, SEM defines the “foreign resident population” differently from the FSIO, as it excludes international officials, their family members, asylum seekers and foreign nationals who were temporarily admitted to Switzerland more than 12 months ago.

[Statistical sources](#)

The data on Switzerland's foreign resident and asylum-seeking populations were extracted from ZEMIS. The ZEMIS Ordinance of 12 April 2006 stipulates the type of information that may be entered into this registry. The communal, cantonal and federal partners regularly share information on changes to the Central Foreign Nationals Register thereby ensuring that the data are not only up-to-date but also of the highest quality. All of the information in the present statistical report has undergone thorough checks. Nonetheless, errors may arise. Please note that SEM does not accept liability for prejudice or damage arising either directly or indirectly from the use of the information contained in the present report.

Glossary

Immigration domain

Permanent foreign resident population

All foreign nationals who have been living in Switzerland for at least one year and who hold one of the following:

- a permanent residence permit
- a residence permit
- a short stay permit
(a period of 12 months or more)

According to the SEM definition, the permanent foreign resident population does not include asylum seekers, diplomats holding a permit issued by the Federal Department of Foreign Affairs, international officials and family members of the foregoing who are not in gainful employment.

Holders of a permanent residence permit

As a general rule, foreign nationals are awarded a permanent residence permit after they have lived in Switzerland for an uninterrupted period of five years (nationals of EU/EFTA States, USA, Canada) or 10 years (nationals of other states). The 10-year qualification period still applies to nationals from one of the 12 States which joined the EU on 1 May 2004/1 January 2008. A permanent residence permit is granted indefinitely and with no conditions attached.

Holders of a residence permit

Foreign nationals who reside in Switzerland for a longer period of time for a certain purpose, with or without gainful employment. The permit is issued for a limited period but can be renewed.

Holders of a short stay permit (period of 12 months or more)

Foreign nationals who reside in Switzerland for a limited period, usually less than a year, for a certain purpose, with or without gainful employment. This permit can be extended by one year or longer.

Recognised refugees

Foreign nationals to whom Switzerland has granted asylum. Recognised refugees receive a residence permit. After five years' residence, they become eligible for a permanent residence permit.

Foreign non-permanent resident population

All foreign nationals who have been living in Switzerland for less than one year and who hold a short stay permit. Service providers staying in Switzerland for no more than 4 months. Foreigners providing services in Switzerland for no more than 90 days per calendar year.

Holders of a short stay permit residing in Switzerland for more than 4 months but less than 12 months

Foreign nationals staying in Switzerland for a period of more than four months but less than one year for a certain purpose, with or without gainful employment. Every year, the Federal Council sets the quantitative limits for this group.

Holders of a short-stay permit residing in Switzerland for no more than four months

Foreign nationals who reside in Switzerland for a period of no more than four months for a certain purpose, with or without gainful employment. This group is not subject to quantitative limits.

Musicians and artists residing in Switzerland for no more than eight months

Foreign nationals who are actively involved in the creation or performance of music or other artistic works. Individuals in this group may reside in Switzerland for a maximum of eight months per calendar year.

Dancers residing in Switzerland for no more than eight months

Foreign nationals from non-EU 28/EFTA States who work as cabaret dancers in Switzerland. They may reside in Switzerland for a maximum of eight months per calendar year. Nationals of an EU-28 or EFTA State are granted a short stay permit or a residence permit in accordance with the Agreement on the Free Movement of Persons. The status of dancer was abolished as of 01.01.2016.

Movement of the foreign permanent resident population

Entries into Switzerland (Immigration)

Foreign nationals who have immigrated into Switzerland during the given calendar year.

Departures from Switzerland (Emigration)

Members of the foreign resident population who have emigrated from Switzerland during the given calendar year.

Net migration

Net migration is the difference between the number of immigrants and emigrants over a given period. It also factors in registration-specific technical adjustments.

The total number of entries (immigration) breaks down as follows:

- Effective entries
- Increases owing to a change of status
- Transfers from the asylum process

The total number of departures (emigration) breaks down as follows:

- Effective departures
- Decreases owing to a change of status

To the net migration increases are added cases of reactivated residence which have been calculated according to earlier automated departures. This also applies to other departures which come under the automated departure category (see definition) and to deleted ZEMIS entries.

Net natural population change

This is the difference between the number of recorded births and deaths.

Net internal migration

This is the difference between the number of entries and departures for a given canton.

Consequently, this category appears solely in the statistics for the canton concerned. Moving to another canton does not affect the net internal migration rate for Switzerland as a whole.

Gainful employment

Persons in gainful employment

All foreign nationals who are gainfully employed on Swiss territory. Since the bilateral agreements between Switzerland and the EU/EFTA came into force, employment statistics can only be produced for short-stay permit holders. This is due to the occupational mobility of EU/EFTA nationals. As a result, labour data on persons among the foreign permanent resident population are recorded only when their first permit is issued or when their status changes. The Federal Statistical Office produces statistics on Switzerland's foreign workforce in collaboration with the SEM and the State Secretariat of Economic Affairs (SECO).

Economic classification

The economic activities of Switzerland's foreign permanent resident population is classified according to the FSO's "General Classification of Economic Activities" (NOGA).

Acquisition of Swiss citizenship

The new Citizenship Act came into force on 1.1.2018. Swiss citizenship may be acquired by virtue of the law or by official decree.

Regular naturalisation

Foreign nationals who have lived in Switzerland for at least 10 years, who are successfully integrated into Swiss society and are familiar with the Swiss way of life may acquire Swiss citizenship through regular naturalisation.

Simplified naturalisation

In particular, foreign spouses of Swiss nationals living in Switzerland or abroad can obtain Swiss citizenship in a simplified procedure. Foreign children with a Swiss parent, stateless minors and third generation foreigners who were born in Switzerland also qualify for simplified naturalisation.

Reinstatement of Swiss citizenship

Individuals who have lost their Swiss citizenship may apply to have it reinstated if they are successfully integrated into Swiss society. If they live abroad they must provide proof that they have close ties to Switzerland.

Declaratory proceedings

If there is doubt as to whether a person holds Swiss citizenship, the authority in the canton, the citizenship of which has been called into question decides, on request or ex officio.

Swiss citizenship by adoption

Where a foreign minor is adopted by a Swiss national, the child acquires Swiss citizenship through the adoptive parent. However, it must be a full adoption.

Net naturalisations

This is the difference between the number of acquisitions and losses of Swiss citizenship.

Asylum domain

Asylum seekers–N permit

Foreign nationals who have applied for asylum in Switzerland and whose application is being processed or who are subject to a removal order.

Provisional admission–F permit

Foreign nationals provisionally admitted to Switzerland who either have not submitted an asylum application or whose asylum application has been rejected.

Temporary protection–protection status S

Members of a specific group are granted S protection status under a simplified procedure. They receive an S permit valid for one year, with the possibility of extension. After at least five years, they can obtain a B residence permit, which expires when the temporary protection is lifted.

Support with the enforcement of a removal order (SER/VU)

The cantons may request federal support to enforce a removal order for individuals awaiting repatriation. This support covers the procurement of papers and/or making the necessary travel arrangements, and may be applied to individuals who had been in the asylum process but are now required to leave Switzerland (support provided during or after the asylum process) and to other foreign individuals covered under the FNA (support provided outside the asylum process). Under certain circumstances, SER/VU may be granted for Dublin cases.

Dublin Agreements

The Dublin Regulation determines the Dublin State responsible for examining an asylum application. This system aims to prevent an applicant submitting an asylum claim in multiple States and to ensure that at least one Dublin State is responsible for handling an asylum case.

Departure following asylum/Dublin decision

This refers to individuals who are removed from the asylum process following an asylum/Dublin decision. Responsibility for them (emergency aid), including the organisation of their removal, falls to the canton to which they have been allocated. However, the canton may request federal support with the enforcement of the removal order.

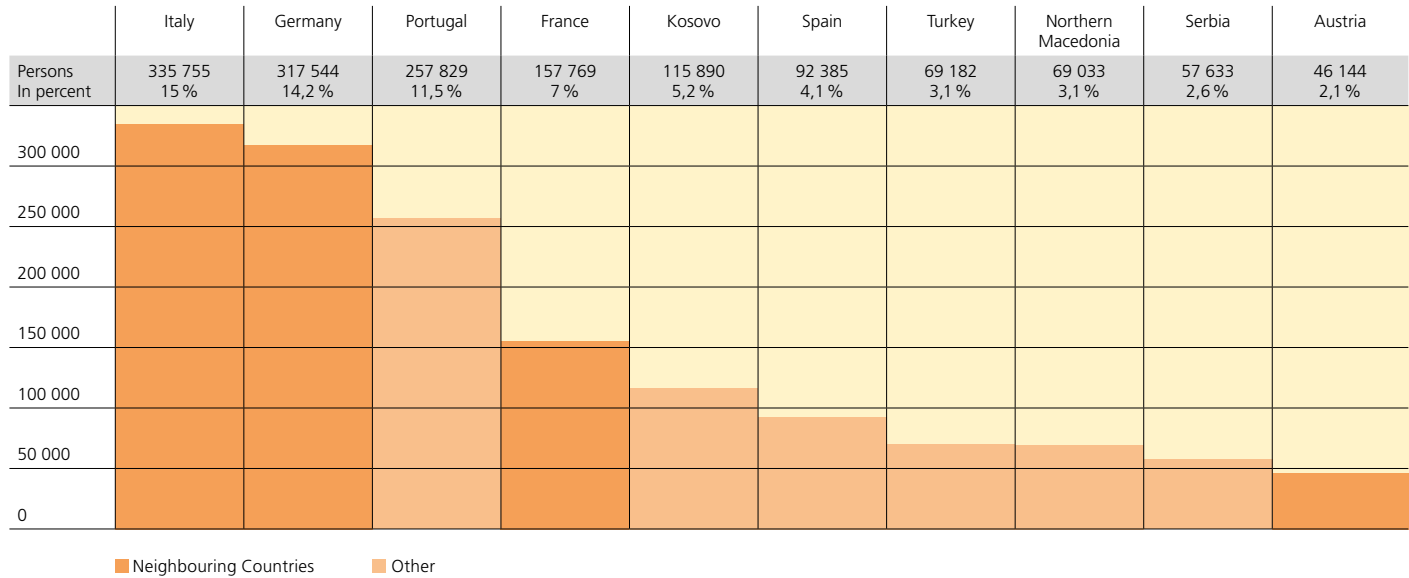

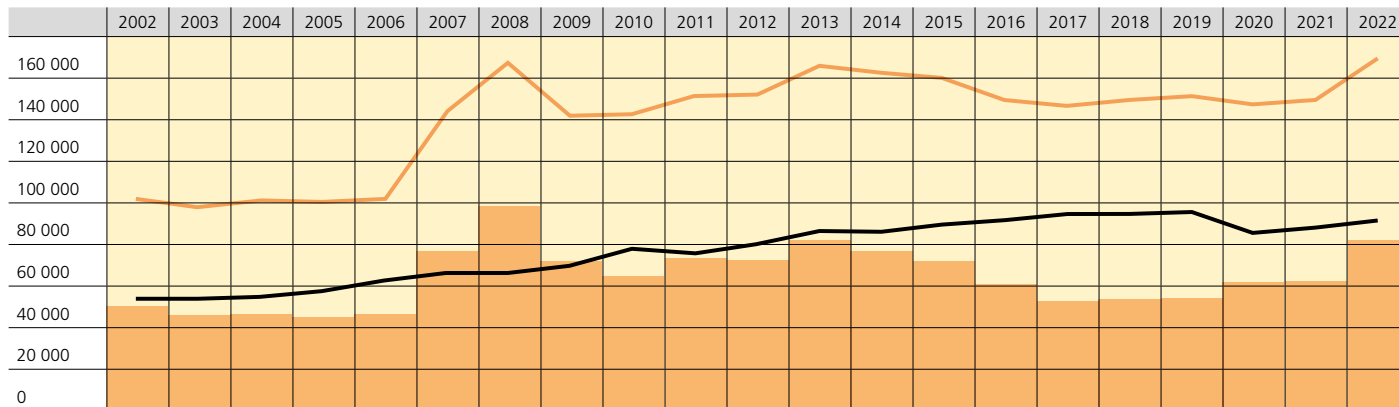

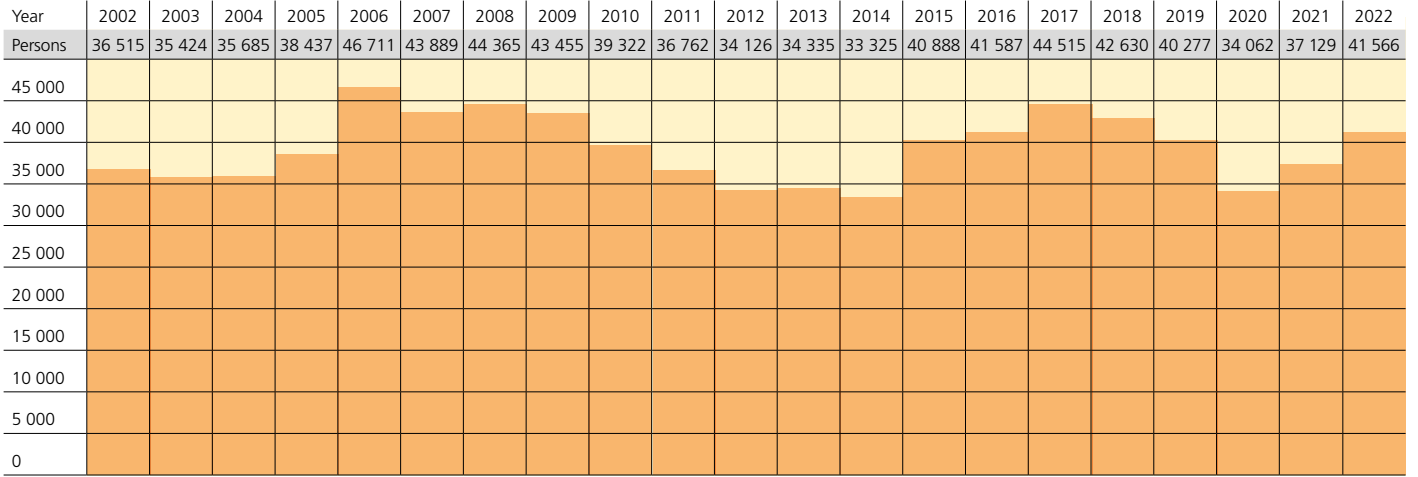

There are three ways of acquiring Swiss citizenship through an official decision. These take account of various circumstances that may apply to foreign citizens:

- *Regular naturalisation* is available to foreign citizens who have lived for at least ten years in Switzerland, three of which must be in the five years before they file their application for citizenship, and who hold a settlement permit (C permit).
- *Simplified naturalisation* is for persons who are married to a Swiss citizen or were born in Switzerland and belong to the third generation of a family of foreign citizens living in Switzerland. In addition, Switzerland has other simplified naturalisation procedures, for example for persons who are stateless.
- *Reinstatement of citizenship* is an option for people who have previously held Swiss citizenship but forfeited, relieved or lost it.

Asylum seekers whose asylum application has been rejected but who cannot return to their country of origin are granted temporary admission. To obtain this status, they must meet one of three criteria: their enforced removal is unlawful (concrete threat abroad; violation of the Human Rights Convention); their enforced removal is not reasonable (war; personal hardship); their enforced removal is not possible (the journey is technically impossible at the time of the removal decision). Since 12.03.2022, Switzerland grants temporary protection to refugees from Ukraine. The persons concerned do not have to go through an asylum procedure, but receive the protection status S in a fast procedure.

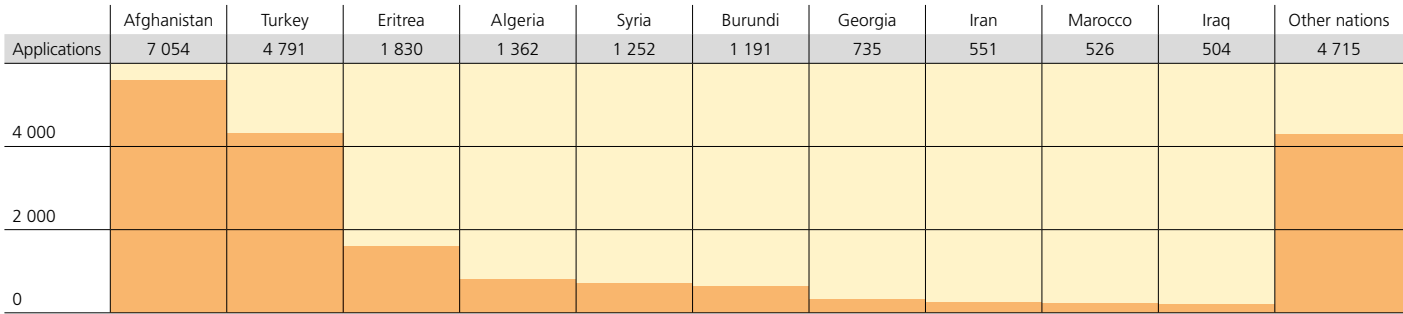

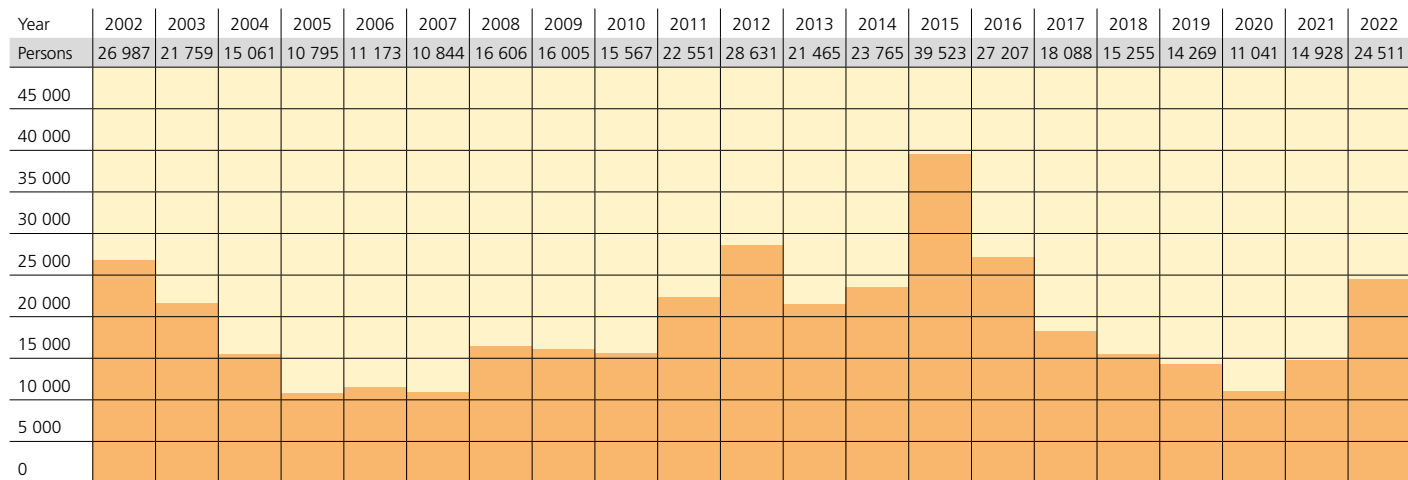
Top 10 nationalities 2022

In 2022, 24 511 asylum applications were filed in Switzerland, 64,2 percent more than in the previous year. The increase in asylum applications is related to the fact that travel generally became easier again with the end of most restrictive pandemic-related measures in spring 2022.
